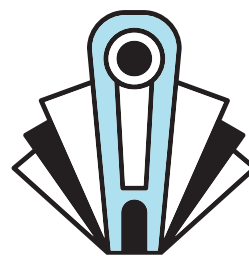

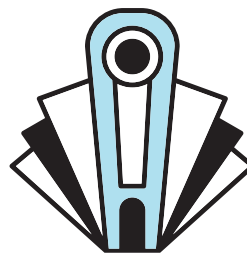

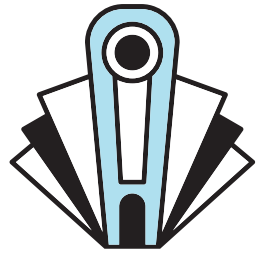

### Notes:

1. You can cancel this declaration at any time by notifying the Heritage Electric Trains Trust
2. If your circumstances change and you no longer pay enough income or capital gains tax to cover the amount claimed by the charity, you can cancel your declaration
3. If you pay tax at the higher rate, you can claim further tax relief via your Self Assessment tax return (currently 25p for each £1.00 you give)\*\*
4. Please notify the Heritage Electric Trains Trust if you change your name or address

\* Gift Aid is linked to basic rate tax. Basic rate tax is currently 25%, which allows charities to reclaim 25p on every £1.00. Tax year is 6th April to 5th April

\*\* Higher rate taxpayers can claim back the difference between basic rate and higher rate tax
